"SUPPLY OF LABOR AND MATERIALS FOR THE REPAIR AND REHABILITATION OF CEILING INCLUDING REWIRING OF POWER AND LIGHTING OUTLETS AT COMMON AREA 4TH FLOOR OF THE ADMINISTRATIVE BUILDING BFAR REGION VII"

- The DA-Bureau of Fisheries and Aquatic Resources Region VII, through the General Appropriations Act (GAA) FY 2023 intends to apply the sum of ONE MILLION PESOS ONLY (Php 1,000,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for "SUPPLY OF LABOR AND MATERIALS FOR THE REPAIR AND REHABILITATION OF CEILING INCLUDING REWIRING OF POWER AND LIGHTING OUTLETS AT COMMON AREA 4TH FLOOR OF THE ADMINISTRATIVE BUILDING BFAR REGION VII". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DA-Bureau of Fisheries and Aquatic Resources Region VII through its Bids and Awards Committee (BAC) now invites bids for the aforementioned project. Completion of the Works is required <u>within Thirty (30) calendar days</u> upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from DA-Bureau of Fisheries and Aquatic Resources-VII and inspect the Bidding Documents at the address given below from 8:00 AM to 4:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on March 13-26, 2023; 8:00 AM to 4:00 PM at BFAR-7 BAC Office, 3rd floor, Arellano Blvd., Cebu City and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by Official Receipt (OR) along with the submission of their bids.
- The DA-Bureau of Fisheries and Aquatic Resources-VII will hold a Pre-Bid Conference on March 14, 2023; 2:00 PM, BFAR-7 BAC Office, 3rd floor, Arellano Blvd., Cebu City, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through (i) manual submission at BFAR-7 BAC Office, 3rd floor, Arellano Blvd., Cebu City, on or before March 27, 2023; 2:00 PM. Late bids shall not be accepted.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on March 27, 2023; 2:00 PM, BFAR-7 BAC Office, 3rd floor, Arellano Blvd., Cebu City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The DA-Bureau of Fisheries and Aquatic Resources-VII reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
