INVITATION FOR NEGOTIATED PROCUREMENT TWO-FAILED BIDDING NO. 2023-05

"SUPPLY OF LABOR AND MATERIALS FOR THE REPAIR/EXPANSION OF PRODUCTION AREA FOR SALT PROCESSING UNDER DEVELOPMENT SALT INDUSTRY PROJECT (DSIP) IN EAST POBLACION, ALBURQUERQUE, BOHOL"

The DA-Bureau of Fisheries and Aquatic Resources Region VII, through the General Appropriations Act (GAA) FY 2023 intends to apply the sum of **SEVEN HUNDRED SIXTY FIVE THOUSAND PESOS ONLY (Php 765,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for "SUPPLY OF LABOR AND MATERIALS FOR THE REPAIR/EXPANSION OF PRODUCTION AREA FOR SALT PROCESSING UNDER DEVELOPMENT SALT INDUSTRY PROJECT (DSIP) IN EAST POBLACION, ALBURQUERQUE, BOHOL". Bids received in excess of the ABC shall be automatically rejected at bid opening.

The procurement procedure for this requirement is Negotiated Procurement pursuant to Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", including Annex H thereof.

The DA-BFAR VII, through its Bids and Awards Committee (BAC), now invites technically, legally and financially capable suppliers for the said procurement indicated above.

The procurement is restricted to Filipino citizens/sole proprietorship, partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock, belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar right or privileges to Filipino citizens, pursuant to RA 5183.

The BAC will engage in negotiations with a sufficient number of suppliers to ensure effective competition. The selection of the successful offer shall be based on the best and final offer that will be submitted on the specified date shown below, and which would meet the minimum technical specifications required.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bids shall be submitted in sealed envelopes, labelled as "Negotiated Documents", with the title of the procurement project, name of the bidder, address of the bidder and contact details of the bidder, addressed to the undersigned. Late bids shall not be accepted.

Bidder's representative may choose to attend the opening of proposals/offers at the place and date indicated.
