BFAR DISPOSAL COMMITTEE INVITATION TO BID (ITB)

<u>Disposal of Unserviceable Motor Vehicles</u>

1. The BFAR 7 Disposal Committee hereby invites all interested parties to participate in the public bidding of **Seven (7) Units Unserviceable Motor Vehicles** on an "**AS-IS WHERE-IS**" basis, subject to the terms and conditions, as follows:

- 2. The above-mentioned unserviceable properties shall be sold to the highest bidder.
- 3. No bids lower than the floor price shall be allowed.
- 4. The unserviceable properties must be inspected by the prospective bidders between May 13, 2024 to May 22, 2024 during office hours only.
- 5. Interested parties may get the bid documents/forms at the BFAR 7 Property Section, with office address at Pier I Area, Arellano Boulevard, Cebu City, and telephone number (032)239-3820, local 112 from 8:00AM 4:00PM on May 23, 2024 to May 27, 2024.
- 6. Sealed bids will be received at the BFAR Property Section on or before **12:00 Noon of May 28, 2024 to May 31, 2024**.

The Bidder shall enclose in a sealed envelope the following:

- a) Fully accomplished Bid Form
- b) Photocopy of the Bidder's Latest and Valid Mayor's/Business Permit. In case of submission of the expired permit, the official receipt will be acceptable as proof if the Bidder has applied for renewal
- c) Photocopy of the Bidder's latest Annual Income Tax Return, stamped "Received By" BIR or its duly accredited and authorized institutions/Tax Clearance or Certificate of Registration, in case of new companies.

- Deposit of at least 10% of the bid price in the form of cash on or before the specified opening time and date of the bidding.
- 7. The envelope containing the above listed items shall be sealed and signed (across the envelope's flap) by the Bidder and properly labelled containing the name of the Bidder and the item/s to bid.
- 8. No Bids shall be accepted once the bidding process commences. A Bidder may be allowed to withdraw a bid tender before the time of opening of bids. The bid shall be returned unopened. Changes shall not be allowed on the bid forms after the deadline for the submission of bids.
- 9. Opening of bids shall be done by the BFAR Disposal Committee (BFARDC) and may be witnessed by the Bidder's or their duly designated representatives on **June 01, 2024 at exactly 10:00AM**.
- 10. The bid tender that is not in the prescribed form/format with the mentioned requirements (e.g., unsigned bid, et.) at the time of the opening of bids shall be considered defective bid and shall automatically disqualify the Bidder.
- 11. After the opening of all bid tenders and evaluation, the unserviceable properties shall be awarded by the BFARDC to the highest bidder. In case of a tie, a new bidding shall immediately be conducted between or among the tied Bidders until such tie is broken.
- 12. Failure of the winning Bidder/Awardee to remit/pay the balance of the amount of the Bid on or before <u>4:00PM three (3) days after receipt of the Notice of Award</u> (NOA) will render the award null and void.
- 13. Upon payment of the full price, the winning bidder shall be the recipient of the unserviceable properties and is required to haul the same within **ten (10) working days**.
- 14. Expenses incidental to the withdrawal of the properties shall be borne by the Awardee.
- 15. The BFARDC shall not, directly or indirectly, in whole or part, entertain any third-party transactions (i.e., second buyers) for the items subject of bid. Any claim with regards to the disposal should be directed to the winning Bidder/Awardee being the official recipient of the unserviceable properties.
- 16. Sale of properties for disposal shall be subject to the existing pertinent government rules and regulations on the matter.
- 17. This ITB shall be posted in at least <u>three (3) public places</u> in the locality on <u>April 30, 2024 to May 10, 2024</u>.

The BFARDC reserves the right to reject any or all the bids with or without cause, to annul the bidding process, to waive any defect in them, and to award to the Bidder whose bid is considered the most advantageous to the government. The decision of the BFARDC is final and binding.








